2010 Basketball Chair Sara Smania, 2010 Softball Chair Jim Buettner, and 2011 Basketball Chair Herman Fuechtmann

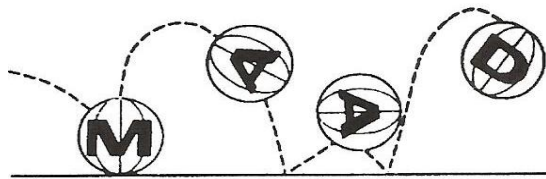
Commissioner Paige Thompson-Matzker wanted to revisit on the audiogram issues re: Chadwick Stevenson because he had signed his name on the form.
