BBDB2022-05: I, Law Committee (DAAD), move that: we remove the "9:00 - 11 pm Delegates Roundtable' from B Tournament Requirement, 1 F. I. **CARRIED.**

BBDB2022-09: I, MAAD Secretary Kiley Peterson (CSA), move that: we test trial for two years for the annual delegates meeting to be once a year after the softball tournament and before the basketball tournament either to be online or in person. **Referred to the Law Committee.**

BBDB2022-10: I, OAD (DAAD), move that: To have the MAAD president propose at USADB that their 55 DB level should be in the *Worst* instead of *Better* ear. **CARRIED.**
